April Final Financials:

Cecilton Activity Report/Speeding Concern: No one was present from the Cecil County Sheriff's Department to review the report. Member West brought up the youth cyclist riding in center lane of traffic/intersection. Continued discussion of calls on the report. Trespassing Concern: Council Member had a video of a youth that has been banned on town property in the park. The police was called by the member. The police are in possession of the information from the Town Attorney, but they cannot enforce it because he is a juvenile. The town attorney was contacted and he said that was not the case. It needs to be determine where the breakdown is. Discussion of how it can be enforced or next steps.

WTTP and Water Supply Report – Operator Jordan Smith was present to review the report. Flows are better. By Friday, all the proposals should be in for the WTTP work.
