Attorney Thomas Yeager gave a quick update on his time at MML Conference. Attorneys Association is trying to get a bill sponsored in the Maryland General Assembly for this upcoming session to eliminate the publishing in the newspaper requirements in the State Code. He will keep us up to date on this issue. Advertising in newspapers can be an expense endeavor.

Member Katzmire commented that many people have asked her on whether they could get chickens in town. At the MML conference she spoke to another town that changed their ordinance to get chickens in town. They put some regulations on it so it would not be bothersome to the neighbors, such as property size and flock size. Also, no roosters. Galena is the town that changed their ordinance. She feels it is something to consider. Attorney Yeager suggested looking at Galena's ordinance for guidelines. Mayor Cooper said that we could put it on next month's agenda. The discussion of the current Avian Flu and affects with chickens. Member West expressed that the county policy is 6 maximum for under an acre.
